



## TERMS AND CONDITIONS

#### I- INTRODUCTION:

These terms and conditions apply to the User who uses the Online Services provided for any payment made to (ICC DMCC). Kindly read these terms and conditions carefully. By authorizing a payment to ICC DMCC through the online payment service, it would be treated as a deemed acceptance to these terms and conditions. ### III- KEY TERMS:

- a- Payment(s) through online payment service at ICC DMCC website, only be made with a Visa or Master Credit Card.

- > UAE Dirham (AED) for users inside UAE.
- United States Dollar (USD) for users outside UAE.
